Guide Dog Program: Guide Dogs of Texas raises, trains and provides quality guide dogs to Texans who are visually impaired giving mobility and independence for living. Currently, 97% of the pups in training are whelped in the program to ensure the highest quality of health and temperament required in a guide dog. Early puppy training relies on volunteers and a very successful prison puppy raising program. Advanced training, client matching and training, as well as follow up services are accomplished with professional guide dog mobility instructors on staff. Follow-up training services are provided for the life of the guide dog client and guide their community in Texas. All expenses are attributed to canine training or human service outcomes.
